Brighton & Hove Seafront (Various Restrictions) Consolidation Order 2018 Amendment Order No.* 202*

Brighton & Hove City Council ("the Council") in exercise of its powers under Sections 1(1), 2(1),4, 45,46, 49, 53, 124 (1) (c) & (d) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

Part 2.2 - No loading at any time

Renumber existing item 1 Madeira Drive to number 4 and item 2 Undercliiff Walk to item 12.
