Introduce bike hangars for secure pedal cycle parking provision and amend existing waiting and parking restrictions to allow for the installation of the hangars in the following locations:

- Zone A Inwood Crescent (outside 49)
- Zone C Ardingly Street
- Zone J Beaconsfield Villas & Rugby Road
- Zone K Clermont Terrace
- Zone N Albany Villas, Eaton Gardens (2 hangar locations), First Avenue (2 hangar locations), Goldstone Road, Grand Avenue, Second Avenue, Shirley Street (2 hangar locations) & Wilbury Road
- Zone O Davigdor Road
- Zone R Cowper Street (2 hangar locations) & Langdale Road
- Zone U Buller Road
- Zone V Arnold Street & Finsbury Road
- Zone Y Montpelier Crescent (outside No.33) & Vernon Terrace
- Zone Z Cavendish Place, Norfolk Terrace & Sillwood Street

## Modification

The proposed installation of the following bike hangars will not be going ahead on this order and will be going to Transport & Sustainability Committee:

- Zone A Inwood Crescent (opposite No.6)
- Zone F Bates Road
- Zone M Adelaide Crescent, Brunswick Place (3 hangar locations 2 of the locations are 2 hangars together), Brunswick Terrace (3 hangar locations) & Lansdowne Road
- Zone Q York Grove (2 hangars together)
- Zone R Poynter Road (2 hangar locations)
- Zone V Hanover Street, Melbourne Street (2 hangars together) & Southampton Street
- Zone Y Montpelier Crescent (outside Nos.7 & 8)
